The Suburban Cook County (SCC) Chronic Disease Prevention Network, led by the Cook County Department of Public Health, is pleased to announce the availability of \$20,000 in grant funding. Additional funds may become available in the future.

Four \$5,000 Model Communities grants will be awarded to local governments and community organizations interested in making policy and environmental changes to support individuals and families in their efforts to lead healthy, active lives. ## Become a Model Community.

Model Communities may use the following types of strategies to improve school, work and community environments.

**Nutrition** Healthy options in vending machines and cafeterias, nutrition information on restaurant menus, community gardens, farmers' markets

**Physical Activity** Increased daily physical education in all grades K-12; more green space, playgrounds, parks and paths for safe walking, bicycling and jogging

**Tobacco** Smoke-free homes, schools, workplaces or parks
